MEMORANDUM OF UNDERSTANDING (MoU)

BETWEEN St. Xavier's College, Ranchi & Ashrayani Foundation
(PaaLoNaa Campaign)

This Agreement is made on this 09th **day of June, 2025** (the "Effective Date") by and between:

St. Xavier's College, Ranchi, located at Dr. Camil Bulcke Path, Ranchi, Jharkhand-834001, hereinafter referred to as "The College".

Ashrayani Foundation, a nonprofit organization registered under Indian Trust Act 1882 (Reg. No: 1396/199/2017) of India, having its Camp office at H/O **Projesh Kumar Das**, Tara Babu Lane, New Colony, Tharpakhna, P.S. Lalpur, Dist. Ranchi – 834001, Jharkhand, and Main Office at PaaLoNaa, 5, Kanke Road, Opposite Speaker's House, Above CN Honda Showroom, Ranchi-834008, spearheading the PaaLoNaa Initiative, hereinafter referred to as "The Foundation".

WHEREAS, The College and The Foundation recognize the importance of preventing infanticide and unsafe abandonment of newborns in India and seek to collaborate in the spirit of academic engagement, social advocacy, and community service.

NOW, THEREFORE, the parties agree as follows:

Article 1: Purpose

This Memorandum of Understanding (MoU) establishes a framework for collaboration between The College and The Foundation to further the cause of infant protection through academic research, student engagement, legal advocacy, and community awareness.

Article 2: Areas of Collaboration

The collaboration will encompass, but not be limited to, the following initiatives:

- **Academic Research & Publications**
Joint research studies, field investigations, and report publications on infant protection, maternal health, social stigma, and related subjects.
- **Student Internships & Social Projects**
Enabling students to contribute via internships, case documentation, community engagement, and grassroots activism.
- **Seminars & Awareness Initiatives**
Co-hosting seminars, workshops, and sensitization drives for students, faculty, and the local community.
- **Volunteer Engagement & Ambassadorship**
Mobilizing students and faculty members as awareness ambassadors, volunteers, and research contributors in the broader cause of infant protection, with inclusive efforts encompassing initiatives such as "Save the Girl Child", alongside PaaLoNaa's core commitment that "Every Infant Matters," irrespective of gender.
- **Curriculum Integration & Knowledge Sharing**
Exploring the integration of infant protection themes into departments such as **Journalism and Mass Communication, Social Studies, Human Studies, Psychology, Law, and Healthcare**, or organizing expert-led lectures and collaborative modules.
- **Alumni and Network Linkages**
Leveraging alumni networks, entrepreneurship cells, and incubators for mentorship, policy discussions, and advocacy support.

Article 3: Roles & Responsibilities

St. Xavier's College, Ranchi shall:

- Facilitate academic research participation and student internships across relevant departments.

- Provide infrastructure support for media production, research workshops, capacity building programs and awareness programs.
- Encourage faculty and student collaboration in content creation, research, and advocacy.

All the above are limits to the practicability of the institution.

Ashrayani Foundation shall:

- Provide mentorship, research guidance, and campaign-building opportunities.
- Facilitate training sessions for journalism, psychology, sociology, and legal studies students.
- Ensure responsible and ethical handling of data collected through student-led projects.

Article 4: Duration & Termination

This MoU shall remain in force for three (3) years from the date of signing.

Either party may terminate the agreement with 30 days' written notice if required.

Article 5: Miscellaneous

- This MoU serves as a formal statement of intent for collaboration, without creating financial obligations.
- Modifications to this MoU shall be made through mutual consent of both parties.


