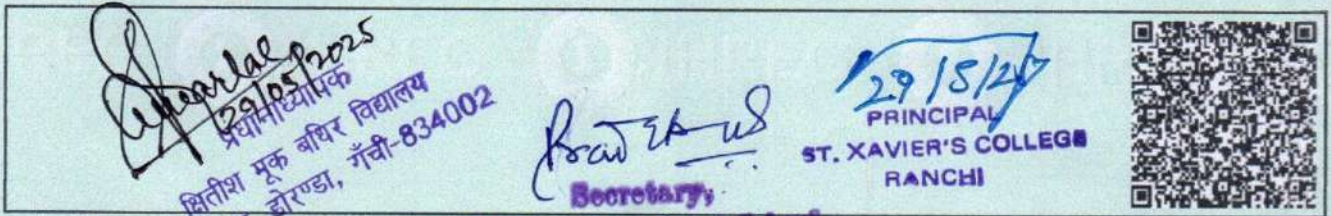



- f. To facilitate internship of students and providing exposure towards inclusive education.


## 3. Proposed modes of Collaboration

- c. This MOU, unless extended by mutual written consent of the institutes, shall expire in 4 (Four) Years.
- d. This MOU can be terminated by either party due to breach of any covenants here of by the other, giving three months notice to the defaulting party.
- e. Both institutions will designate co-ordinator who will have responsibilities for co-ordination and implementation of this agreement.
- f. Both institutions will not have any financial liability on either party.

## 5. Conflict Resolution


