



MEMORANDUM OF UNDERSTANDING FOR ACADEMIC AND SCIENTIFIC COOPERATION



Between

And

Department of Zoology, St. Xavier's College, Ranchi, Jharkhand

Purpose

The purpose of this Agreement is to promote cooperation in quality education and scientific research between the Brainology Scientific Academy of Jharkhand (BSAJ), Ranchi, Jharkhand And Department of Zoology, St. Xavier's College, Ranchi, Jharkhand

Types of Cooperation

Through this memorandum, both Parties affirm the value of educational collaboration and agree to promote the following activities:


1. Joint research projects in fields of mutual interests;
2. Exchange of academic publications and reports;
3. Opportunities for faculty and staff development and exchange;
4. Exchange of visiting research scholars, including graduate and undergraduate students;
5. Other activities as mutually agreed.

This Agreement places no financial obligations or supplementary funding commitments on either Party. These activities will be defined through separate program agreements that detail the commitment of resources (financial or otherwise) required by each Institution. Subsequent program agreements must be approved in writing by the authorized representatives of each institution.

Secretary cum Founder Director Miss Dolly Krishnan of BSAJ and Dr. Priya Srivastava of the Zoology Department of St. Xavier's College will serve as the primary liaison between the two institutions to facilitate the development of future activities.

Terms

This agreement will become effective upon the date of the signature by both Parties. It shall remain valid for a period of 5 years from the date of the last signature, with the understanding that it may be modified by written mutual consent of both Parties. This agreement may be terminated by either Party with advance return notice of at least 30 days. Upon notice of termination both BSAJ and St. Xavier College Ranchi agree to work in good faith to enable visiting scholars to complete their respective research program unhindered by the termination. The agreement may be extended by mutual consent of two parties after the five year period and it must be renewed in writing.
