NOW, THEREFORE, THIS MoU WITNESSETH AS UNDER:

1. Purpose

2. Scope of Collaboration

- - The Company agrees to provide On-the-Job Training (OJT), Project Training, Internships, Final Year Project support, and Real-World Project exposure to selected students of the Department.
- - The training will include exposure to live projects, hands-on sessions, team-based development environments, and mentoring by industry professionals.
- - Training may be conducted in online, offline, or hybrid mode, based on mutual agreement.
- - Duration of OJT, internship, or project training, batch size, and schedule shall be decided jointly by both parties.
- - A certificate of completion will be awarded by the Company to all students successfully completing the training or project work.

3. Responsibilities of the Company

- - Provide a structured training plan and assign mentors.
- - Evaluate the students' performance during the OJT or internship.
- - Offer industry insights, technical guidance, and real-time exposure to tools and technologies.
- - Maintain attendance and performance records.

4. Responsibilities of the Department

- - Nominate eligible and interested students for OJT, internship, or project work.
- - Coordinate with the Company for scheduling and monitoring the training.
- - Facilitate necessary permissions, if required, from the college administration.
- - Provide feedback and support for improving the training process.

5. Confidentiality

Both parties agree to maintain the confidentiality of proprietary and sensitive information shared during the course of this engagement.

6. Duration and Termination

- - This MoU shall remain in effect for a period of two (2) years from the date of signing and may be renewed upon mutual consent.
- - Either party may terminate the MoU by giving one month's written notice to the other party.

7. Dispute Resolution

Any dispute arising out of this MoU shall be resolved amicably by mutual discussions. In case of failure, the matter shall be subject to the jurisdiction of the courts in Ranchi, Jharkhand.
