# MEMORANDUM OF UNDERSTANDING BETWEEN GOSSNER COLLEGE, RANCHI AND

# ST. XAVIER'S COLLEGE (Autonomous), RANCHI

#### 1. PARTIES TO THE AGREEMENT

This Memorandum of Understanding (MoU) is made and entered into this 17 day of May, 2025, by and between:

- Gossner College, Ranchi, located at Club Road, Ranchi 834001, Jharkhand, India, affiliated to Ranchi University, hereinafter referred to as "Gossner College"/FIRST PARTY.
- St. Xavier's College, Ranchi, located at Purulia Road, Ranchi 834001, Jharkhand, India, affiliated to Ranchi University, hereinafter referred to as "St. Xavier's College"/SECOND PARTY.

Both institutions are hereinafter collectively referred to as the "Parties" and individually as a "Party". FIRST PARTY and SECOND PARTY As Referred earlier/ABOVE.

#### 2. BACKGROUND

Recognizing the mutual interest in the fields of higher education, research, academic excellence, and social development and other extra-curricular activities, the Parties desire to establish a collaborative relationship to

- Access to libraries, laboratories, research centers, and other facilities subject to institutional rules.
- Sharing of best practices in curriculum design, teaching methodologies, and academic administration.

#### 4.4 Joint Program Development

- Development of joint certificate/diploma programs and special training courses.
- Curriculum enrichment initiatives through interdisciplinary and innovative programs.

# 4.5 Community Outreach and Social Initiatives

- Organization of extension activities, social outreach programs, and community development initiatives.
- Participation in service-learning projects and volunteering programs.

# 4.6 Sports and related activities

 Organize joint sports events and encourage to participate at national level competitions and enhance physical fitness and mental activity.

#### 5. TERMS AND CONDITIONS

#### 5.1 Roles and Responsibilities

- Each Party shall appoint a MoU Coordinator/Nodal Officer to oversee, coordinate, and facilitate activities under this MoU.
- Specific collaborative activities will require the formulation of a separate agreement, detailing the objectives, roles, responsibilities, timelines, and financial implications.

## 5.2 Confidentiality

 The Parties agree to maintain confidentiality regarding any confidential information shared during the course of the collaboration and shall not disclose such information to any third party without prior written consent.

# 5.3 Intellectual Property Rights

 Any intellectual property created jointly shall be owned jointly by the Parties, and terms regarding its protection and commercialization shall be agreed upon separately for each project.

# 5.4 Financial Arrangement

- This MoU does not create any financial obligation for either Party.
- Financial arrangements for specific activities or programs shall be determined separately and in writing.

6. VALIDITY AND TERMINATION

- This MoU shall be valid for a period of five (5) years from the date of signing.
- The MoU may be renewed or extended by mutual written agreement of the Parties.
- Either Party may terminate this MoU by giving a One (1) month prior written notice to the other Party, without assigning any reason.
- In the event of termination, ongoing activities shall be allowed to conclude unless otherwise agreed upon.

#### 7. AMENDMENT

This MoU may be amended or modified only by a written instrument signed by authorized representatives of both Parties.

#### 8. DISPUTE RESOLUTION

- Any dispute arising out of or in connection with this MoU shall be resolved amicably through mutual discussion.
- If a resolution cannot be reached, the dispute shall be referred to a committee consisting of two representatives from each institution.

#### 9. GENERAL PROVISIONS

 Nothing in this MoU shall be construed to create a partnership, joint venture, or employer-employee relationship between the Parties.

ST. XAVIER'S COLLEGE

- This MoU is not intended to and does not create any rights or obligations under law that are enforceable against either Party.
- The Parties acknowledge that they enter into this MoU in good faith.
