MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) sets for the terms and understanding between

ST. XAVIER'S COLLEGE RANCHI

and

HULLADEK RECYCLING PVT. LTD.

It sets forth guidelines and responsibilities for establishment and operations of a Community Collection Point for Electronic waste collection as a collaborative project.

PURPOSE-

The shared objective of this partnership, in compliance with E Waste (Management) Rules, 2016 and amendments thereafter, is to provide solutions for effective collection and channelization of Electronic Waste procured in the city by the society at large and is signed on this 9th September 2023.

The above purpose/goal will be accomplished by undertaking the following activities:

DELIVERABLES FROM HULLADEK RECYLCING PVT. LTD.

- To install 1 (one) "E-Waste Collection Bin" at ST. XAVIER'S COLLEGE, Dr Camil Bulcke Path,
 Pathalkudwa, Nayatoli, Ranchi, Jharkhand 834001 or any other location as prescribed by ST.
 XAVIER'S COLLEGE from time to time, and if need arises, additional bin(s) would be placed in
 the facility on prior notification.
- 2. To install 1 (one) digital weighing scale for ease of material weighing and recording of data.
- To pick up, transport, carry and dispose of the E Waste from ST. XAVIER'S COLLEGE which will be collected through this collection point, accessible by college student and faculty members.
- To share relevant formats/documents to St. Xavier's College like logistics sheets, receipts, material reference sheets etc.
- 5. To ensure proper training and information sharing to the representative(s) who will be handling the operations in the facility of ST. XAVIER'S COLLEGE as mentioned in "Deliverables from ST. XAVIER'S COLLEGE" in point no. 1 below.
 Any updates in the rules, processes or operational formalities that may be implemented by Hulladek, will have to be communicated prior to the ST. XAVIER'S COLLEGE to avoid any delays or confusions.

- 6. To install marketing or branding material in and around the premises as follows:
 - Hoardings
 - Banners
 - Posters

The branding and marketing materials can be provided by HULLADEK as mutually decided by both organisations according to decided frequency and quantity.

- To make available E Waste Recycling Certificate to the individuals who drop in their E Waste, confirming that E Waste provided has been disposed/recycled as per norms prescribed by the Government Authorities, within 60 days from the days of material lifting.
- To provide a contribution/ donation to ST. XAVIER'S COLLEGE towards their help in the
 activity on a per kg basis (i.e., Rs. 12/-kgs) on total collection from time to time in the
 collection bin. For the E waste generated from the college with be given a rate mention in
 Annexure.
- To arrange seminars and awareness sessions at regular intervals in the facility to promote proper E Waste disposal for a sustainable environment.
- To ensure regular communication, reporting and data handover from ST. XAVIER'S COLLEGE to keep the process and certification flow uninterrupted.

DELIVERABLES FROM ST. XAVIER'S COLLEGE:

- To assign one representative who will be available during the defined time slots, to conduct
 operations for collection and execute necessary formalities.
- 2. To sign required documents acknowledging that E Waste has been handed over to Hulladek.
- To ensure that all E Waste procured and in possession of ST. XAVIER'S COLLEGE will be exclusively given to Hulladek.
- To accumulate all E Waste in the "E Waste Collection Bin" provided by Hulladek and pass on the information once the bin is full.
- To share branding collaterals during seminars and events to maximize reach and promote the collaboration.
- To handover all duly filled documents to Hulladek at a set frequency, within a time frame of four weeks.
