This Memorandum of Understanding has been executed on 4 / 10 / 2025 through the Chief functionaries of the parties.

- I. **Kalinga University** is accredited by NAAC with B+ grade and attained NIRF Ranking 2025 in the Top 101- 150 universities in the country. It is the only University in Chhattisgarh to have achieved an NIRF ranking in the Top 101-150. It has been established as a multidisciplinary Research-Focused and Student-Centric University with the aim to support learning that will advance human knowledge to develop and educate the leaders of tomorrow in research that tackle the most pressing problems of the state, the country, and the global community.
- II. Second Party is an educational institution, namely, St. Xavier's College (Autonomous), located at Dr. Camil Bulcke Path (Purulia Road) Ranchi, accredited by NAAC in the year 2023 and awarded B+ in the fourth cycle serving the student community at Under Graduate and Post Graduate levels. The college has AICTE approved BCA and BBA programmes in addition to B.A., B.Sc., B.Com. honours and honours with research under CBCS and NEP 2020.

1. Purpose and Objectives:

The parties recognize the benefits to be derived from mutual collaboration, cooperation and interaction towards the empowerment of the teachers and learners. Hence, the parties desire to work together with the following objectives:

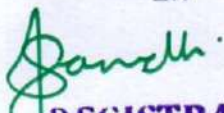
- 1.1 To provide a platform for the teachers, the Research Scholars and the students of both institutions to progress, perform and hone their teaching skills to match-up to the ever-changing and challenging times in education, by organizing seminars, conferences, symposia, workshops and mentoring programmes based on the needs and demands of the stakeholders without financial dependencies.
- 1.2 To cultivate and inculcate a research temperament that fosters an innovative ecosystem, for the teachers and the scholars of both institutions.
- 1.3 To conduct outreach programmes, to aid the less fortunate, to upgrade their knowledge and skills.

- 1.4 To organize faculty development programmes so that the teachers of both the institutions can update their knowledge base and implement the best pedagogical practices.
- 1.5 To encourage and emphasize the Professors, Associate Professors and others to participate and contribute as a resource faculty.
- 1.6 To establish a regional platform for the students/teachers.
- 1.7 To strengthen the educational relationships between both the institutions for the welfare of the teachers and learners.

2. Discretion:

This Memorandum of Understanding (MOU) is subject to the following:

- 2.1 That the final authority in regard to its implementation and coordination of its activities shall rest on the Registrar of Kalinga University, Naya Raipur Chhattisgarh -492101 and the authorized signatory of the second party.
- 2.2 That the Memorandum of Understanding will remain valid for five (5) years from the date of signing with the possibility of further renewal, and such renewal is subject to evaluation and subsequent agreement on the part of both the Parties.
- 2.3 Both the Institute agree that this Memorandum of Understanding may be amended by mutual agreement and that each organization may unilaterally withdraw after six months' notice to the partner.
- 2.4 Both the parties will appoint a Nodal officer responsible for executing the programme.
- 2.5 The functionaries / Nodal officers shall meet at least once in three months for planning and implementation of the programmes via video conference or face to face based on everyone's availability.
- 2.6 The MoU will not result to any financial obligation to either partner.
- 2.7 The copyright will be reserved by both the parties.

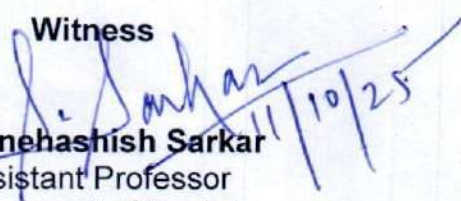
