This Agreement

is made and entered into on this ^{10th} day of April 2026, at Ranchi, Jharkhand, by and between:

1. Parties:

1.1 A Kautilya Enterprise, a registered company having its principal place of business at Ranchi, Jharkhand having offices at 4th Floor, MR Tower, Line Tank Road, Ranchi 834001 (hereinafter referred to as the "*First Party*"), representing **G-TEC Education** (www.gteceducation.com) through a valid and subsisting *Master Franchise Agreement*, which provides globally recognized IT, skill-development, and vocational-training programs.

AND

1.2 St. Xavier's College, Ranchi, an autonomous educational institution affiliated with Ranchi University, having its workplace cum campus located at Dr. Camil Bulke Path, Ranchi – 834001 (hereinafter referred to as the "*Second Party*").

The *First Party* and *Second Party* shall hereinafter collectively be referred to as the "*Parties*" and individually as a "*Party*."

2. Purpose of the AGREEMENT

3. Scope of Collaboration

- b) Delivering practical and industry-relevant learning experiences in areas such as business analytics, accounting tools, financial modelling, digital marketing, and related disciplines.

- c) Organizing faculty-led interactive sessions with industry professionals & experts for orientations, learning and understanding through seminars, workshops, talks and applied project-based learning.

- d) Facilitating exposure opportunities for students to technology-driven business practices through G-TEC's methodologies.

- e) **Ensuring that the curriculum for each session is curated in accordance with the guidelines and academic approval of the St. Xavier's College**, thereby aligning with the institution's educational objectives and quality standards.

- f) In addition to the above, the **First Party can provide specialized courses including Tally, Tally with GST, Data Analytics, Generative AI, Python, and other advanced skill-based or emerging technology programs***, as per Institutional approval and student demand.

4. Roles and Responsibilities

A. A Kautilya Enterprise (First Party)

- To plan, design and deliver the sessions in consultation and coordination with the Dept. of Commerce, St. Xavier's College, Ranchi.
- To provide professional experts in form of trainers, design learning contents/tools/ IEC and relevant study materials for sessions as well as future learning referrals for students.
- To provide guidance and assistance to students interested in pursuing additional professional certifications offered by G-TEC Education.

B. St. Xavier's College (Second Party)

- To nominate students and coordinate logistics for the agreed sessions and events.
- To provide **classroom and lab facilities**, including computers, internet access, and software installations necessary for the sessions.
- To oversee and approve the session curriculum and its alignment with departmental standards and inform any ambiguities.
- To facilitate smooth conduct of sessions as per this agreement, ensuring the academic timelines not being compromised.

5. Exclusion Clause

The Parties expressly agree to the following:

1. These **Skill Sessions** are **purely training, capacity building oriented and practical in nature**, intended to enhance students' applied understanding of subject areas.
2. All logistical **facilities (lecture rooms, laboratory and other infrastructure)** required for the conduct of these sessions shall be **provided by St. Xavier's College, Ranchi**.
3. This AGREEMENT **does not include or cover any professional certification programs** offered by third-party vendors such as **Tally, Zoho, SAP**, or similar providers.
4. Students interested in obtaining such **professional certifications** shall contact **A Kautilya Enterprise representatives directly** to learn about certification fees, curriculum, and registration requirements.
5. If a student wishes to **earn formal Skill Credits** as per the **National Credit Framework (NCrF)** guidelines, they must **apply for and enroll in an appropriate credit-based course** offered through G-TEC Education or a recognized credit-linked program approved by competent authorities. Participation in the current instructional sessions **does not automatically confer credit equivalence** under (NCrF) unless explicitly stated in such a program.
6. This platform and arrangement must NOT BE USED to advertise or stimulate students towards any commercial set-ups like professional courses run by **A Kautilya Enterprise** representing **G-TEC Education** or any other Party.
7. **St. Xavier's College** shall neither employ nor directly or indirectly engage, absorb or appoint any faculty provided by A Kautilya Enterprise during the term of this Agreement and thereafter & without prior written consent of '**A Kautilya Enterprise**'.
8. Any Communication from the **St. Xavier's College** with the **A Kautilya Enterprise** must be conducted only through an authorized channel of the **A Kautilya Enterprise** and not through faculty members.

6. Commercial Terms

2. A valid GST invoice shall be raised for the course, and payment shall be made by SXC against such invoice

7. Validity and Duration

This AGREEMENT shall remain valid for **two (2) years** from the date of signing and may be renewed by mutual written consent.

8. Confidentiality

Both Parties agree to maintain confidentiality of all shared academic or proprietary information and to not disclose such information without prior written consent.

9. Intellectual Property Rights

All course materials, contents, IEC and frameworks provided by A Kautilya Enterprise (under G-TEC Education) shall remain its intellectual property.

St. Xavier's College shall not reproduce, publish or distribute these materials without written authorization and consent of **A Kautilya Enterprise** (under G-TEC Education)

10. Dispute Resolution and Jurisdiction

Any disputes arising under this AGREEMENT shall be resolved amicably through mutual discussion.

In case of unresolved matters, such disputes shall be subject to the **exclusive jurisdiction of the courts at Ranchi, Jharkhand, India.**

11. Termination

The AGREEMENT shall stand automatically terminated from the succeeding day of concluding day of this arrangement, if the parties do not renew this in writing.

During the tenure, either Party may terminate this AGREEMENT by giving **30 (thirty days') written notice** to the other Party. Obligations
