

MEMORANDUM OF UNDERSTANDING (MoU)

And
Prabah Vocational Skill Foundation

This Memorandum of Understanding ("MoU") is made and entered into on this 11th day of October, 2025, by and between:

St. Xavier's College, Ranchi, an educational institution affiliated to Ranchi University under Section 2(f) and 12(b) the provisions of the University Grants Commission Act, 1956, Established by 'Xavier's Ranchi under Society Registration Act having its office at [Dr. Camil Bulcke Path, Purulia Road, Ranchi-834001], hereinafter referred to as "the College" (which expression shall include its successors and permitted assigns);

AND

Prabah Vocational Skill Foundation, Q No B 2492 HEC Colony sector 2 side 5 DHURWA Ranchi PIN code 834004 Jharkhand a not-for-profit organization registered under Section 8 of the Companies Act, 2013, having its registered office at [Q No B 2492 HEC Colony sector 2 side 5 DHURWA Ranchi PIN code 834004 Jharkhand], hereinafter referred to as "the Foundation" (which expression shall include its successors and permitted assigns).

PREAMBLE

Recognizing the urgent need to promote academic excellence, industry collaboration, digital transformation, innovation, and skill development, this MoU lays the foundation for a strategic partnership between the College and the Foundation. This partnership is aligned with the objectives of the National Education Policy (NEP) 2020 and is committed to fostering holistic and multidisciplinary education.

1. OBJECTIVES OF THE MOU

The purpose of this MoU is to facilitate a long-term institutional partnership between the College and the Foundation to:

- a) Enhance employability through internship and placement support.
- b) Organize capacity-building programs, including Faculty Development Programs (FDPs), Student Development Programs (SDPs), and leadership workshops.
- c) Establish Innovation Cells, AI Labs, and incubation centers within the campus.
- d) Promote digital skills, entrepreneurship, and research in emerging technologies.
- e) Facilitate institutional transformation to build sustainable and industry-aligned educational models.
- f) Encourage collaboration with corporate partners under CSR as per Schedule VII of the Companies Act, 2013.
- g) Support the college in achieving NAAC, NBA, and NIRF ranking goals.
- h) Conduct national and international conclaves, seminars, webinars, and academic conferences.
- i) All programs will adhere to the guidelines issued by UGC, AICTE, and other regulatory bodies.

2. SCOPE OF COLLABORATION



2.1 Responsibilities of the Foundation:

- a) Design, implement, and evaluate training modules tailored to the needs of students and faculty.
- b) Provide strategic advice in developing curriculum frameworks aligned with NEP 2020.
- c) Assist in setting up Innovation Labs.
- d) Offer industry-relevant mentoring, assessments, and certifications.
- e) Engage industry leaders, policymakers, and subject matter experts for conclaves and boot camps.
- f) Enable collaborations with corporates for internships, projects, and funding support.
- g) Monitor and report the impact of all programs and recommend improvements.

2.2 Joint Responsibilities:

- a) Facilitate infrastructure and logistics for program delivery.
- b) Designate nodal faculty members to oversee program implementation.
- c) Integrate programs and activities within the academic calendar.
- d) Ensure active participation of faculty and students.

e) Share the resources, data, and support as needed.

f) Both the College and the Foundation shall make best efforts to jointly mobilise and arrange funds through CSR partnerships, UGC /State Funding grants, and other collaborative mechanisms to implement mutually agreed activities under this MoU in a sustainable manner, while ensuring compliance with applicable regulations.

2.3 Financial Obligation

The MoU will not result in any financial obligation and neither MoU partner will not be required to make any payment to the other partner for the collaboration mentioned in the MoU.

3. DURATION

This MoU shall remain in effect for three (3) years from the date of execution and may be renewed by mutual agreement in writing.

4. INTELLECTUAL PROPERTY RIGHTS

Intellectual Property (IP) jointly developed under this MoU will be shared equally unless agreed otherwise under a separate agreement. Each party retains rights over independently developed content, materials, and branding, which will require prior approval for any joint use.

5. CONFIDENTIALITY

Both parties shall maintain the confidentiality of sensitive data and information exchanged under this MoU in compliance with applicable data protection laws, including the DPDP Act, 2023.

6. AMENDMENTS AND TERMINATION

This MoU may be amended with sixty (60) days' prior written notice and with mutual consent. It may be terminated by either party with sixty (60) days' written notice.

7. INDEMNIFICATION

Each party agrees to indemnify and hold the other party harmless against any claims, damages, or liabilities arising due to acts or omissions attributable to the defaulting party.


8. LIMITATION OF LIABILITY

Neither party shall be liable for indirect or consequential damages, except in cases of gross negligence, wilful misconduct, or fraud.

9. MISCELLANEOUS

- Force Majeure: Neither party shall be liable for failure to perform obligations due to events beyond reasonable control.
- Entire MoU: This MoU constitutes the entire understanding between the parties.

- Notices: Notices will be sent in writing to the addresses of the designated authority and a copy will send to the nodal persons of each party.

Disputes if any at any point of time during the validity period of this MoU will be resolved amicably.


11. LEGAL COMPLIANCE
