MEMORANDUM OF UNDERSTANDING

1. Purpose

- Generate Self-employment opportunities.

WHEREAS

- First party is a Higher Educational Institution named: Department of Zoology, St. Xavier's College, Ranchi.
- First party and Second party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- The parties intent to co-operate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.
- Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest.

1.2 The co-operation between First Party and Second Party will facilitate effective utilization of the intellectual capabilities of the Second Party providing significant inputs to them in developing suitable teaching/ training systems, keeping in mind the needs of the First Party.

1.3. The general terms of co-operation shall be governed by this MOU. The parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents as may be required to give effect to the actions contemplated in terms of this MOU. The term of definitive documents shall be mutually decided between the parties. Along with the definitive documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

Clause 2: SCOPE OF THE MOU

2.1. The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believes that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

2.2. **Curriculum Design:** Second party will give valuable inputs to the first party in teaching / training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.

2.3. **Industrial Training & Visits:** Industry and institution interaction will give an insight into the latest developments / requirements of the industries; the second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the First Party.

2.4. **Internships and Placement of Students:** Second Party will actively engage to help the delivery of the Internship and placement of students of the First Party into internship / jobs.

2.5. **Research and Development:** both parties have agreed to carry out joint research activities in the fields of common interest.

2.6. **Guest Lectures:** Second party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements.

2.7. **Faculty Development Programs:** Second party to train the Faculty of First Party for imparting industrial exposure / training as per the industrial requirements considering the National Occupation Standards in concerned sector, if available.

2.8. Both parties to obtain all internal approvals, consents, permission, and licenses of whatsoever nature required for offering the Programs on the terms specified herein

2.9. There is no financial commitment on the part of both the Parties. If there is any financial considerations, it will be dealt separately.

Clause 3: Confidentiality

Both parties agree to maintain the confidentiality of proprietary information exchanged during the collaboration and not to disclose such information to any third party without prior written consent.

Clause 4: Intellectual Property Rights

Any intellectual property developed jointly during the course or internship will be co-owned, unless otherwise agreed upon in writing.

Clause 5: Duration and Termination

- **Effective Date:** 28th of May, 2025
- **Term:** This MoU remains in effect for 5 (five) years from the effective date.
- **Termination:** Either party may terminate the MoU with a 60 days written notice.
Ongoing programs at the time of termination will be allowed to conclude as planned.

Clause 6: Dispute Resolution

Any disputes arising from this MoU will be resolved amicably through mutual discussions.

Clause 7: Amendments

Modifications to this MoU must be made in writing and signed by authorized representatives of both parties.

Clause 8: Point of Contact

Dr. Manoj Kumar, Department of Zoology, St. Xavier's College, Ranchi will serve as the primary liaison between the two institutions to facilitate the development of future activities.
